



Breeding Contract 2019

Stallion: "Turpys Dual (ET) " AQHA No Q76773

The following Breeding Agreement is between the Stallion Owner Dianne Bennett (trading as Turpentine Park Quarter Horses/Turpentine Park QH) and the Mare Owner.

By signing this agreement, the Mare Owner agrees to and accept all the terms and conditions as laid out in the Agreement.

This Agreement is made on --/ --/ ----. The parties hereto contract for the servicing of the said Mare by the said Stallion for the 2019 Breeding Season which ends 31st January 2020 on the following conditions:

1. Breeding Fee \$1,650 (incl of GST) plus Vet, Shipment and Agistment costs.
\$550 non-refundable Booking Fee is included and payable on signing this breeding contract to Dianne Bennett.
The balance of Breeding Fee (\$1100) is payable upon a positive 45 day pregnancy check.

2. The Mare Owner understands that the amounts stated above do not include any veterinary, semen collection and shipment, agistment or other costs incurred in achieving this pregnancy of which will be payable by the Mare Owner.

3. Turpys Dual may be unavailable for collection of chilled/fresh semen between the dates of 9th September 2019 to the 24th of September 2019 due to show commitments , however , Frozen semen is always available.

4. A Live Foal Guarantee (LFG) is given for one foal with the return privilege the following season. It is understood that if the mare aborts or the foal does not stand up and nurse, the Mare Owner will be entitled to a return privilege. This guarantee applies if the mare owner notifies the stallion owner within one week from the date of abortion or death of the foal. This notice must be accompanied by a statement from a licensed veterinarian stating the cause of death. A Rebreed contract must be filled out and returned to Turpentine Park QH. No breeding service fee will be charged but a \$220 Stallion Handling Fee and other expenses including vet, shipment and agistment incurred in achieving the rebreed shall be bourne by the Mare Owner. If the Mare Owner fails to request a rebreed the following year, then any and all fees shall be forfeited and this contract hereby cancelled. The LFG for this contract is non refundable, transferable and non-assignable unless authorised by Turpentine Park QH. Should the mare be sold or otherwise disposed of prior to the birth of the foal, the LFG shall be void unless prior authorisation by Turpentine Park QH.

5. Is this semen to be shipped? YES NO (circle one)

6. If semen is to be shipped, Seven Creeks Equine Veterinary Clinic reserves the right to approve all locations where the semen is to be shipped to and will only ship to those locations which are trusted to handle and account for the semen properly.

7. Seven Creeks Equine Veterinary Clinic and the Stallion Owner guarantee to ship the highest quality semen, however, will make no warranties or guarantees and shall not be held liable for the contamination or damage of semen during or after shipment, loss of viability or any cost arising from shipment delayed, damaged or lost in transit.

10. If more than one foal results from any one (1) embryo flush, an additional Breeding Fee of \$1,650 will be due and payable to Dianne Bennett on each successful pregnancy of said embryo(s).

11. Mare Owner(s) agrees to notify Seven Creeks Equine Veterinary Clinic and Turpentine Park QH the results of the 45 day pregnancy check and an invoice will be issued if positive. A 'Breeders Certificate' will be issued when all monies due under the agreement have been paid.

12. The mare's AQHA registration certificate showing owner(s) at time of breeding or a photo copy, both sides, thereof, must be returned with this contract. Any Mare Owner wishing to seek registration with other breed societies must purchase and provide the relevant breed certificate to the Stallion Owner for completion.

13. Semen will not be shipped until the booking fee is paid in full and a signed contract and copy of mare's registration papers are on file at Turpentine Park QH.

14. Recommended 24 – 48 hours notice must be given to Seven Creeks Equine Veterinary Clinic and Turpentine Park QH prior to needing semen.

15. The Mare Owner warrants that the mare is in good health and has not been in contact with any infectious diseases. Seven Creeks Equine Veterinary Clinic and Turpentine Park QH reserve the right to refuse the breeding of any mare. Diligent efforts will be made to settle the mare (having bred her through at least 3 breeding cycles), however, if the mare fails to settle for any reason, the Mare Owner agrees to hold the Stallion Owner and breeding farm blameless.

16. If the stallion dies, is sold, transferred or becomes unfit for collection of semen, this agreement will be cancelled and the Stallion Owner released from any further liability upon notice to the Mare Owner and a refund of the Breeding Fee paid to the Mare Owner (less any monies outstanding for vet, shipment and agistment fees) and neither party shall have any rights against the other.

15. This contract shall not be assigned or transferred by the Mare Owner without written consent by the Stallion Owner.

16. When the Mare Owner, or authorised representative, signs and returns one copy of this contract to the Stallion Owner and it has been approved it will then become a binding contract on both parties subject to the above terms and conditions.
